Improper parking concerns can be given to the Sheriff's office. CJ Trucking, HD Equipment, Grand Mound Co-Op, Ajs Bar and Grill, Crystal Creek Farms, Campbell Grain Farms, and JJJ Enterprises have donated park benches to be placed around the walking trail at the Ballpark. ISG will be preparing light options for the trail. Once a project plan is complete for the solar lights, the City will provide more details on the availability and cost if a business, or individual would like to donate a light and place a plaque on the light as a donation or in honor/memory of someone. Sidewalk inspections from last year and this year will be sent out this spring in addition to nuisance letters concerning excessive junk/junk vehicles located on properties.. As a general reminder junk items and junk vehicles are required to be stored inside of an enclosed structure.
