Ordinance No. 308-23 Amending Chapter 17.06 Compensation City Council was introduced by Banowetz with waiving the 2nd and 3rd reading with a second by Schanze. Roll Call: Schanze-Aye, Beitelspacher- Aye, Banowetz- Aye, Marlowe- Nay, Beuthien- Nay. Ordinance No. 308-23 was signed by Mayor Crosthwaite and passed.

Resolution No. 23-14 Fireworks Purchase was introduced by Beuthien, with a second by Beitelspacher. Roll Call: Schanze- Aye, Beitelspacher- Aye, Banowetz- Aye, Marlowe- Aye, Beuthien- Aye. Mayor Crosthwaite signed the resolution.

Reports: A large tree was improperly disposed of at the compost pile. A city wide clean up day is not an option due to the misuse of a similar program in past years. Dumpsters are available for citizens to rent at a fee of \$15.00 per week. The Museum is working on a collaboration with Dewitt's historical society and updating literature and viewing hours. The ballpark had storm damage which was reported to the ball club with the option for an insurance claim if needed. There is a large tree damaged in the alley near 903 Sunnyside street. A request to Alliant Energy for possible assistance with the tree due to power lines was submitted. A tree is damaged in the boulevard near 906 Sunnyside. The PWD will contact the property owner to discuss options regarding the tree. CIT completed televising the main line through the field to the lagoons which showed I&I. A full report will be provided at the May meeting. GMCCC will be contacted to discuss adding a camera in the water shed, a conference phone at the council desk, mini projector/chrome cast and projector screen with city council chambers. May 9th at 7:00 p.m. there will be a presentation from the University of Iowa students working with ISG on the wastewater lagoon BES project at City Hall. A special meeting was requested to be held at a later date regarding a public works employee's performance.
