Motion by Beuthien, second by Beitelspacher to close the 500 block of Smith Street on July 16th for a street dance. Insurance certificates to be provided prior to July 16th. Ayes; All.

Motion by Beitelspacher, second by Marlowe to authorize Precision concrete cutting to complete a free survey based on ADA sidewalk guidelines. Ayes; All.

Ball Club Member, S. Beuthien presented interest in having a new restroom built or rebuilding the current restroom for the ballpark and asked if the City would assist in the design and funding. The lease the City has with the Ball Club would need to be amended to allow the City to assist in improvements for the restroom. The City will turn the water on by Wednesday afternoon and the Ball Club will work on looking to add new toilets to the existing restroom while the project is considered in conjunction with a potential update to the concession stand/pavillon and a future possible splash pad, grants pending.

Motion by Beitelspacher, second by Schanze to authorize the Mayor to sign the Calhoun-Burns & Associates Bridge Inspection Agreement. Ayes; All.

Motion by Schanze, second by Banowetz to set a public hearing for FY22 Budget Amendment #2 on May 9th, 2022 at 6:55 p.m. Ayes; All.

Motion by Banowetz, second by Beitelspacher to authorize the Mayor to sign the Sanitary Sewer Manhole Replacement Contract with Needham Excavating. Ayes; All.

Flow Meter- No motion to purchase. City will contact ISG to get the project complete to move the flow meter to prevent backflow readings.

Motion by Schanze, second by Beitelspacher to convert the current part time position to full time with benefits by adding 11 additional hours per week to the part time schedule. Ayes; Schanze, Beitelspacher, Marlowe, Beuthien. Nayes: Banowetz. Motion passed.

The first reading of Ordinance No.306-2022 as revised waiving the second and third reading was introduced by Banowetz with a second by Beuthien. Roll Call: Schanze- Aye, Beitelspacher-Aye, Banowetz- Aye, Marlowe- Aye, Beuthien- Aye. Mayor Crosthwaite signed the Ordinance.

Resolution No. 22-15 J&M Displays Fireworks Display Agreement and Authorization to purchase fireworks was introduced by Schanze with a second by Beitelspacher. Roll Call: Schanze-Aye, Beitelspacher-Aye, Banowetz-Aye, Marlowe-Aye, Beuthien-Aye. Mayor Crosthwaite signed the Resolution.

Reports: The compost pile is being abused. A lot of garbage being left there and people dumping from outside of city limits. Illegal dumping will be prosecuted. The LWCF Grant for the splash pad was rejected due to the City not owning the ballpark and the lease being with the Ball Club who is a non-public entity. The City was not selected for the spring CCDA grant for the splash pad. WGML will have a meeting on 5/11/22 at 6:00 p.m. at the Wheatland City Hall to vote on bids for a new garbage truck. ISG will be contacted to move forward with estimates and completing the project to move the flow meter. The remaining LED trail light fundraising goal is \$5,825.00.

Motion by Schanze, second by Marlowe to adjourn at 8:27 p.m. Ayes; All. The next Regular City Council meeting will be held at 7:00 p.m. on Monday, May 9th, 2022 at City Hall located at 615 Sunnyside St. in Grand Mound, IA 52751.
