ISG, Lenny Larson, presented information on the wastewater compliance strategy. Mr. Larson will follow up with N. Lange on reviewing the flow results and discussing options such as an I&I study, additional flow meter, televising, sludge judge testing/removal.

The museum roof is set to have repairs to the shingles and additional venting completed within the warranty by Giese Roofing in May.

Council Member Fischer announced his resignation effective 04/13/2021. Motion by Beuthien, second by Fischer to Fill the vacancy by appointment on May 10th, 2021. Interested parties to fill the vacancy may contact City Hall or Mayor Kurt Crosthwaite. Ayes; All.

Reports: Potholes have started to be filled. The City park will be getting pea gravel around the playground equipment. The cost for flow meters to be added to the lift stations on the north side of the railroad tracks will be reviewed. The City's property tree stumps from the derecho will be removed within the next few weeks. The general public is invited to attend a grand re-opening of the Depot on May 1st at 10:00 a.m. Information related to Ragbrai on July 30th is posted at www.cityofgrandmound.org. The City received a \$1,000.00 grant from ICAP for the street sweeper and \$825.00 from Lincolnway Foundation towards the park benches to be installed along the Ballpark trail. Additional park benches were donated by American Mutual Insurance, Davisson Tiling, Diva Tej, John Juhl, and Marv's remodeling. The City is working on light options to be added to the trail as well.
