The Clinton County Sheriff's report was read.

City Attorney's Report: Attorney Pillers was absent.

The Fire Department building is in need of a new roof. The Department will provide bids for the January budget meeting. The Department requested the Council to consider an increase to the yearly 28E agreement for services. The agreement will be reviewed at the January council meeting.

A request to ban leaf burning or placing restrictions on burning leaves was reviewed. Council will not ban leaf burning, but will address specific complaints of leaves being left to smolder and cause excessive smoke through the nuisance section of the City Code. As a general reminder, leaves can also be taken to the compost pile located South of town near the sewer lagoons.

Motion by Schanze, second by Fischer to set the employee review committee meeting for January 9th, 2019 at 5:55 p.m. Ayes; all.

Motion by Schanze, second by Fischer to set the budget workshop for 6:00 p.m. on January 9th, 2019. Ayes; all.

Motion by Fischer, second by Beuthien to award an end of year bonus of \$150.00 to full time employees and \$100.00 to the part time employee. Ayes; all.

Motion by Brix, second by Fischer to donate \$100.00 to Crime Stoppers. Ayes; all.

Council discussed having a tree, located near the site where the fireworks are displayed at the BallPark moved once the trail design is complete.

Motion by Schanze, second by Beuthien to donate \$650.00 to HomeTown Pride. Ayes; all.

Motion by Brix, second by Fischer to authorize entering into the Iowa DOT Federal-Aid Agreement for TAP project (Ball Park Trail) Agreement No. 20-TAP-112 Project No. TAP-R-3032 (601)-8T-23. Ayes; all.

Council took no action to add an after hours reconnect fee/service. If service is disconnected for non payment, it will be turned back on during the Public Works Department's scheduled office hours.

Motion by Schanze, second by Fischer to table Resolution No. 19-37 Setting the Budget Max Levy Rate. Ayes; all.

Reports: Two hydrants were tested and one may be able to be rebuilt and the other is recommended to be replaced. Quotes to change over the City Hall building and Maintenance shop to LED lighting will be presented at the January meeting. Obtaining a quote for solar power for the City metered services was suggested. The City's tree near 402 Smith street needs to be addressed (trimmed or removed). The Museum is in the process of having a mural painted inside by Terry Rathje. The light to be added at the corner of Prairie Lane and Washington Street is in process.
