How does my gift help?

Your gift to the Greater Grand Mound Community impact Endowment Fund is invested and grows forever to improve the Grand Mound Community.

How is the fund directed?

This charitable fund is a permanent account whereby the earnings will be earmarked, dedicated and allocated each year. A committee will make an annual selection from the grant applications. The recipients of the grants will continue working on improvements for the community.

How do endowments work?

Endowments are invested in a diverse portfolio by professional wealth managers. Endowments pay out up to 5% annually. The remainder is reinvested to ensure that funds exist into perpetuity.

How do I make a gift?

We welcome gifts at any time and accept cash as well as stocks, bonds and IRAs. Donors may name and honor or remember friends and family through their gifts or name the endowment in their wills to create a legacy that will forever benefit the community.

What is Endow Iowa?

Endow Iowa is a 25% state tax credit for gifts to endowed funds. Upon receipt of your gift to the Greater Grand Mound Community Impact Endowment Fund, you will receive a voucher that can be used the same as cash to pay your state tax. Gifts of \$50 or more are eligible for Endow Iowa.
