City Attorney's Report: Attorney Pillers reported no required updates with the 2021 Legislative summary. A letter from Brandt was received and Attorney Pillers with respond.

Larson, from ISG recommended a splash pad not be discharged to the sewer lagoons at this time with the current NPDES and reviewing the I&I and flows/televising. An alternative would be a recirculating system or to apply for a permit with the DNR to discharge a splash pad to stormwater. General cost estimates will be provided for the two options.

Larson, from ISG will be submitting a disadvantaged application requesting a 5 year extension on the NPDES permit. PW Dept will be having the line televised and Larson will review the flow meter and move it to a higher elevation.

Motion by Warren, Second by Schanze to have the ARPA funds (\$88,371.03 total, ½ \$44,185.52 FY21 and the other ½ FY22) planned to be spent on the Visu-Sewer Quote for sewer televising, Sewer manholes, and reimbursing the water and sewer funds equally for the utility meters purchased 7/12/2021. No ARPA funds to be spent on employee premium pay. Ayes; All.

Reports: The trail light project numbers will be ready for the October meeting. The City Code does allow for new construction to be required to add sidewalks, the building permit application will be updated to reflect this requirement. The 300 block of East street's road will be reviewed to have the area that is raised up, milled or possibly replaced. Oct 5th, 2021 Ranger Power will have an open house at the Community Center regarding the solar panel project. The pot holes in town will be filled before the end of the season. Election paperwork is due to the City Clerk by 5:00 p.m. on Thursday, September 16th 2021.
